Membership Qualifications**

Qualifications: The membership of ACEC/PA shall consist of Member Firms, Associate Member Firms, Affiliate Member Firms, and Supplier Member Firms meeting the requirements below and shall be represented by Resident Principals (proprietors, partners, officers, or managers). Each Member Firm, Associate Member Firm, Affiliate Member Firm, and Supplier Member shall maintain compliance with the membership requirements of the bylaws of the Association.

An Associate Member Firm Shall:

- (a) be an independent firm engaged in private practice to provide professional services of a scientific and technical nature that are complementary to the services provided by Member Firms;
- (b) not be eligible for membership in ACEC/PA as a Member Firm as described in Section 2.
- (c) not supply goods or services that are specified by consulting engineers.

- (d) maintain and have established offices for their private practice as a sole proprietorship, partnership or corporation in the Commonwealth of Pennsylvania;
- (e) have high professional repute and ethical standards;
- (f) become an Associate Member of ACEC if the firm so desires and meets the eligibility requirements of ACEC;
- (g) authorize its Resident Principals to act in its behalf in activities of ACEC/PA; and
- (h) not be eligible to vote on ACEC/PA business, serve on the Board of Directors, or hold office in ACEC/PA, but may be a chairperson or member of a committee.

Associate Membership Dues**

Index Number

For the fiscal year beginning June 1 the firm Index Number will be determined from the total number of full time equivalent employees in a firm using the formula:

(“No. of Employees” to the power of 1/1.75)

The chart at right provides a partial listing of employees and index numbers.

The maximum Index No. for ACEC/PA is 60.0

Firm Dues

\$225 per firm – required for every firm

Membership Dues

Dues for ACEC/PA will be determined by multiplying the Index Number by:

ACEC/PA Dues: \$250

Example: Firm with 10 Employees

Index No. – 3.7

Firm Dues \$225
ACEC/PA Dues \$925
Total Dues \$1,150

Contributions or gifts to ACEC/PA and ACEC are not deductible as charitable contributions for income tax purposes. However, they may be deductible as ordinary and necessary business expenses subject to restrictions imposed as a result of association lobbying activities.

New members joining ACEC/PA and ACEC will receive a 67% reduction in dues for the first year or partial year of membership and a 33% reduction for the second year. Application must be received by April 1.

Membership dues are pro-rated monthly for the fiscal year ending May 31 and will be billed upon approval of the application by the Board of Directors.
